RULES AND REGULATIONS

ELIGIBILITY: Anyone with a valid South Dakota fishing license, a completed and signed entry form and a paid entry fee of \$30 per person.

TACKLE AND EQUIPMENT: Artificial or live bait may be used. Each contestant may use two fishing rods. Minimum of two persons per boat, maximum of four (fishing entrants only).

FISHING AREA AND BOUNDARIES: Platte-Winner bridge to Fort Thompson dam. All boats must leave from and return to Cedar Shore Ramp.

FISHING HOURS: The first flight Saturday will start at 7 a.m. and must check in no later than 4:30 p.m.. The second flight will start at 7:15 a.m. and must check in no later than 4:45 p.m.

SCORING: Prizes will be based on most weight, pounds and ounces. Seven fish will be weighed. No more than two fish may be over 20". Whether you catch fish or not, your team MUST check in at the weigh station. All state laws apply.

TEAMS: Contestants MUST enter as two, three or four person teams. Each team must have a representative in attendance at the rules meeting to be held June 16, 2009 at 7 p.m. in the Sanford USD Medical Center, Meeting rooms A & B. No door prizes will be saved for teams not represented at this meeting.

MISCELLANEOUS: Entrants are responsible for their own meals and reservations. Patrol boats will be in the area. Refreshments are included in the entry fee.
