Sanford USD Medical Center offers three ASHP Post Graduate Year One (PGY1) Pharmacy Residency positions. The program is a 12-month commitment with a start date of July 1. Qualifications & Application

All residency candidates must meet the following prerequisites:

- Earned a PharmD degree from an accredited college of Pharmacy
- Hold an active pharmacy license, or be eligible for licensure in South Dakota

Application materials and deadline will be managed through PhORCAS:

- · Letter of intent
- Curriculum Vitae
- Academic transcripts
- Three reference submissions

Applicants considered for a position will be invited for an interview with pharmacy administration, preceptors, current residents and will be required to review and present a brief case study.

Stipend & Benefits

The stipend is competitive and updated annually. Additional compensation is available for optional per diem staffing shifts. Contact the Residency Program Director for the most current information.

Residents are provided paid health insurance and 24 days of Paid Time Off. All required travel expenses are also covered.
